It was inspired by the 1760s *Lunar Society* – a group of philosophers, business leaders, scientists, and amateur experimenters who met on the nights of the full moon to share and debate ideas over long dinners. Through their collaborations, these individuals together became the catalyst for the industrial revolution.
